Poker prizes awarded at approximately 1:00 p.m. *Must be present to win!*

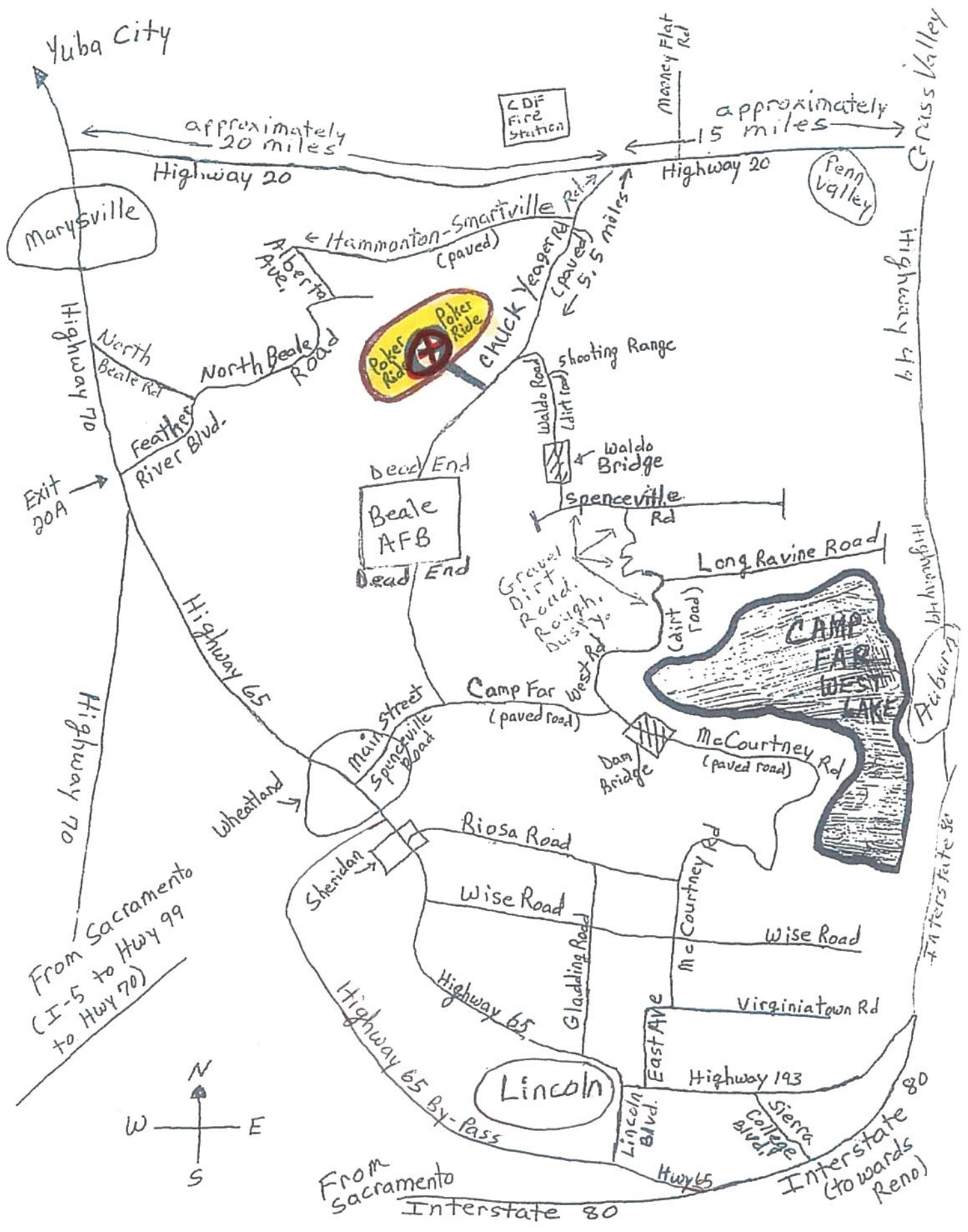

I agree that this release/agreement includes injury or damage caused in whole or in part by negligence, active or passive, of the Ride, State of California Department of Fish and Wildlife, SFHA, and its members, employees, landowners, agents, and contracting parties.

Due to the 2019-2023 outbreak of the novel Coronavirus (COVID-19), SFHA is taking extra precautions.
