7301 Filbert Avenue in Orangevale (near Hazel Ave. and Oak Ave.)

This is a TWO-DAY EVENT! Come back on Sunday for the TACK SWAP!

The Obstacle Trail Challenge will test the ability of each horse and rider to maneuver through a series of trail obstacles. Each obstacle will have its own judge who will individually score each horse and rider. At the conclusion of the ride, all of the scores will be tabulated and prizes will be awarded to the highest placings per each Age Division (including the Leadline Riders) and also the In-Hand Division.

EVENT START TIME: Check-in starts at 7:30 a.m.

8:30 a.m. - riders' meeting for anyone who wants to participate.

9:30 a.m. - Age Division competition starts. Small groups of riders will start & enter the arena every 20 minutes, then exit arena to complete "on-the-trail" obstacles. (At check-in, riders will sign up for a time slot and will be able to select their own group - can be mixed with all ages of riders: families, friends, etc.)

After Age Division & In-Hand competition is done, a lunch break will be held, awards presented, then the Jackpot Obstacle Challenge will start.

CASH \$\$\$ JACKPOT \$\$\$ prizes will be awarded!

NOTE: If a horse is being entered in an Age Division and also in the In-Hand Division, the horse must be ridden first in Age Division before doing the course again as an In-Hand entry. **Ride 1st. In-Hand 2nd.**

We will be taking pre-registrations up until Thursday, April 24th. Enter and pay on-line.

ENTRY FEE—mark with an "X" for age division you are entering (rider's age as of **Jan. 1, 2025**):

Open to any age exhibitor and any age horse/pony (can be either saddled or unsaddled) - the horse/pony will be led through the obstacles without a rider. If the horse is entered in both an Age Division and In-Hand, the horse must be ridden first in the Age Division before doing the course again as an In-Hand entry.

- ___ \$19.99 → IN HAND:
- ___ \$10.00 → Leadline Riders: 7 years and under
- ___ \$10.00 → Rider: 9 years and under
- ___ \$10.00 → Rider: 10 to 13 years
- ___ \$19.99 → Rider: 14 to 17 years

Leadline Riders: Saddled with the rider mounted. The horse/pony will be led through the obstacles (lead rope must be attached to a halter that is either over or under the bridle).

Based on the price of these entry fees, we will **NOT** have to charge/collect the \$14.00 CA Equine Drug Fee.

___ \$45.00 → Rider: 18 to 59 years (this entry fee includes the \$14.00 CA Equine Drug Fee)

___ \$45.00 → Rider: 60 years and over (this entry fee includes the \$14.00 CA Equine Drug Fee)

___ \$30.00 → **JACKPOT OBSTACLE CHALLENGE** – Rider Age: **OPEN TO ALL** (please no Leadliners).

Everyone is encouraged to sign up for **BOTH** - your age division competition and this Jackpot Obstacle Challenge (**horse must be ridden and rider not assisted**). If we do not have at least 10 riders for the Jackpot, it will not be held. \$20.00 from every Jackpot Obstacle Challenge entry fee will go into the JACKPOT. If you do not sign up to compete in your age division competition and you only want to compete in the Jackpot, then you will have to pay the additional \$14.00 CA Equine Drug Fee for your horse.

ADD a \$10.00 POST ENTRY FEE per rider if NOT entered BY APR. 24th

\$ **TOTAL ENCLOSED** Enter on or before April 24th to avoid the post entry fee.
There will be an additional \$20.00 charge for a check returned for any reason.

I am aware that participating in this event involves the risk of injury (including permanent disability and death) to the person or property of the minor(s).

As lawful consideration for being permitted to participate in this event, I hereby agree that I, my heirs, personal representatives, and assigns will indemnify, defend, hold harmless, and will not make a claim against or sue the Event, Orangevale Recreation Park District, SFHA, all officers, directors, members, employees, agents, contractors, guests, invitees, and affiliated entities from all actions, claims, or demands for any personal injury or property damage resulting from my participation in the Event and extends to any personal injury or property damage to the minor(s). I agree that this release/agreement includes injury or damage caused in whole or in part by negligence, active or passive, of the Event, Orangevale Recreation Park District, SFHA, and all members, employees, landowners, agents, and contracting parties.

SFHA/event management will not be responsible for any injury or loss that may occur at the event. Owners, exhibitors/riders, managers, coaches, trainers, etc. shall hold the event management, SFHA, and Orangevale Recreation Park District harmless and indemnify them against any proceedings arising from such injury/loss.

I also acknowledge that my contact info may be used for marketing purposes. Any and all dogs must be on leash at all times. I am fully aware that once I have entered the event that there will be no refund except for obvious injury or illness to horse or rider. In case of inclement weather, no refunds will be given once the event has started – at that point, the event will continue per rain or shine. Event management reserves the right to prohibit any person/horse from participating and to remove any person/horse from the grounds without being liable for compensation, and reserves the right to refuse any entry at any time because of disrespect for the rules, unsportsmanlike behavior, rough treatment of animals, or any other reason officials may deem reasonable cause.

I HAVE CAREFULLY READ THIS AGREEMENT. I UNDERSTAND THAT THIS IS A COMPLETE RELEASE OF LIABILITY AND PROMISE NOT TO SUE OR TO MAKE A CLAIM.
